

THE BEAT DREAM 2023

July 1/2, 2023 in collaboration with the municipality of Santa

Margherita Ligure the fourth edition of "The Beat Dream" dance event will take place.

TBD aims to provide a prestigious international showcase for all dancers

and choreographers participating, from amateur to professional but above all it wants to give the opportunity for everyone to study with internationally renowned dancers and choreographers.

The event will consist of COMPETITION and WORKSHOP.

These Regulations define how the event will be held.

COMPETITION July 1, 2023 in the Bindi Amphitheater located on the sea promenade.

(In case of bad weather the entire event will be held at the "Palazzetto dello Sport" in Santa Margherita Ligure)

WORKSHOP July 2, 2023 at the halls adjacent to the Palazzetto dello Sport.

COMPETITION CATEGORIES

CREW, SOLOS and DUO can participate in the COMPETITION.

CREW categories (minimum 3 components)

- kids under 8 years of age
- NEW GENERATION: 8/11 years of age.
- JUNIOR: 12/14 years of age.
- YOUTH: 15/17 years of age.
- MASTER A: 18 years and older
- MASTER B: 12 elements and up from 18 years of age.
- experimental (no age limit and any style)

- PROFESSIONAL Only 8 crews will be allowed to participate, which will be selected by video.

"Outliers" (maximum 2 years older) are allowed with the following pattern:

- with 1 element if the group is composed of no more than 6 elements
- with 2 elements if the group is composed of 7, 8 or 9 elements
- with 3 elements if the group consists of 10 or more elements

Soloist Categories

- UNDER 14 (14 YEARS OLD)
- OVER 14

COUPLES

- UNDER 14 (14 YEARS OLD)
- OVER 14

For categories involving under 18 years of age, each participant must have with him or her an identification document available to the jury for checks on the year of birth in case of disputes, under penalty of disqualification of the Crew.

AUTHORIZATIONS

- All members under 18 years of age must be authorized by their parents or legal guardian, who, by signing the waiver/single form, assume full responsibility regarding the participation, custody and care of the minor, for the entire period of the event, releasing the Organization from any responsibility.

By signing and signing the releases you also declare that you are in possession of regular medical certificate for non-competitive sports activity The medical certificate (valid on the day of the race and of the correct type) .

Participation implies approval of these regulations in every article.

SCORING AND JURY

- The international panel of judges will consist of renowned choreographers and dancers, and their judgment will be

unappealable

- The judges will give each performance a score expressed in figures from 0 to 10 and decimals (e.g. 5.10-6.20 etc.)

TECHNICAL ASPECTS AND MUSIC

The stage measures length m. 10 and depth m. 10. without backstage

There are no stage rehearsals.

For spectators who wish to attend The beat dream event, admission is FREE, while we

reminded that during the WORKSHOP no public access is allowed.

The audio track of the performance must be sent to the email address info@tbeatdream.it in mp3 format by 24/06/2023

IMPORTANT: the same track must be brought to the event on a usb (as an additional security in case of misunderstandings)

Track length:

-CREW Categories.

The duration of the track must not be less than 2 minutes and 30 seconds and more than 4 minutes with an 5% excess deviation

-SOLO Categories.

The duration of the piece must be 1 minute and 30 seconds with a 10% deviation

-COUPLES Categories.

The duration of the piece must be equal to 2 minutes with a 10% deviation

-Experimental and Professional

The duration of the track must be equal to 2 minutes and 30 seconds up to a maximum of 5 minutes

In the event that the track has a longer duration, the choreographer must notify the organization and have permission to perform with that track.

FEES AND HOW TO REGISTER

Entries are made online at the website by filling out the form www.tbeatdream.it

Entries will absolutely close on 24/06/2023 at 12 noon and/or upon reaching the number maximum number of participants scheduled for each category.

COMPETITION Registration:

CREW: 25€ (per dancer)

SOLISTS: 30€

COUPLES: 30€ (per dancer)

All fees will experience a €5 increase on June 18, 2023

Each member who participates in more than one choreography must add to the basic entry fee the amount of

15€ for each additional choreography, paying full price for the most expensive category.

Example: if an entrant participates in the Competition in a CREW and also performs in a SINGLE, he/she will have to

pay 30€ (for the SINGLE with full price, being the most expensive category) + 15€ for the participation with the CREW.

(if you want to participate in more categories you will have to add 15€ for each additional category)

VIP

5 classes + up to a maximum of 4 categories of your choice: 150€

Participants who are eligible for prize money should request the documentation

Disbursement of the prize money will be made by bank transfer.

Each category enters the competition provided there are at least 3 registered Crews.

The organization reserves the right to cancel a section of the competition or the entire event if force majeure reasons intervene. in which case the fees will be refunded.

The organization reserves the right to make changes and improvements to these regulations at any time and to publish the updated regulations at www.tbeatdream.it

In case the asd/ssd representing the competition registration is not an asd/ssd affiliated with AICS, it will be necessary to include within the registration fee the VAT percentage as per the law, as they are considered commercial activities it is mandatory to increase the registration fee by the 27% VAT percentage.
